Credit transfer Those undertaking Training Services Australia's TAE40116 Upgrade course will be given credit transfer for six of the ten units required to complete the qualification.

Frequently asked questions

- Q. I have already completed the LLN unit. Do I still need to attend the Address adult LLN skills module?
- A. No you will be given a credit transfer for TAELLN411 or TAELLN401A, and therefore not required to attend the LLN module.
- Q. I have already completed the Design and Develop Assessment Tools unit. Do I still need to attend the TAE Assessor Upgrade module?
- A. This depends! You will be given a credit transfer for TAEASS502, TAEASS502A or TAEASS502B. However, you will still need to demonstrate competency for TAEASS401 and TAEASS403. If you are experienced at developing and validating assessments for nationally recognised units of competency, you may wish to seek RPL for these units. If not, it is recommended that you attend the TAE Assessor Upgrade module. You will be given a modified assessment which recognises that you have previously completed the Design and Develop Assessment Tools unit.

Assessment requirements

Both modules of TSA's Assessment Upgrade course include post-course assessment tasks which you will need to complete and submit to TSA for assessment.

The timeframe for completing the assessment tasks is approximately 3 – 4 months per module. Extensions of up to 3 months a provided where a formal request is received, and additional extensions may be allowed in exceptional circumstances.

Resources provided

Training Services Australia provides students with the following resources for each module:

- Assessment document

Electronic copies of the assessment document and other useful resources are made available to students through TSA's website.

Support provided

Training Services Australia provides email and telephone support to students throughout the program.

The course fee also includes assessment support workshops for those who need them.

One-on-one coaching is also available at an hourly rate.

Credential issued

Students who successfully complete all requirements for the upgrade will be issued with a nationally recognised qualification: TAE40116 Certificate IV in Training and Assessment.

Recognition of Prior Learning

Recognition of Prior Learning (RPL) is available for this qualification upgrade.

To be granted RPL, students must provide evidence of their competence to a TSA assessor. Evidence requirements may vary, depending on the unit(s) of competency being assessed. However, they typically include answers to theory questions, work samples and supervisor reports. Students must also participate in an assessment interview with a TSA assessor.

Those who are considering seeking RPL are invited to speak with a TSA Training Advisor. The Training Advisor will make an initial assessment of the student's suitability for RPL and discuss the RPL process in detail before sending an application kit.
